SERVICE AGREEMENT/TERMS AND AGREEMENTS

• HOW DO I PAY FOR THE DUMPSTER?

RCR accepts cash, checks and all major debit/credit cards. Payment is due upfront and covers one service period and one dump, unless otherwise specified. A debit/credit card **MUST** be kept on file for any additional charges that may arise.

• HOW LONG IS A SERVICE PERIOD?

We offer service periods of 7, 14, and 30 days and automatically renews on the last day of the service you selected and paid for. If at any time you no longer need the waste removal service and wish to cancel this contract, please call [\(337\)552-8708](tel:(337)552-8708).

• WHAT CAN I PUT IN THE ROLL OFF DUMPSTER?

RCR can accept the following types of waste:

- Household appliances such as stoves, washers and dryers, furniture, clothing, and general household items.
- C&D Waste (Non-hazardous solid waste resulting from construction and demolition activities) including:
 - Cardboard (No more than 5% of load)
 - Carpeting
 - Fiberglass
 - Insulation (Foam)
 - Light fixtures (Not lamps)
 - Lumber
 - Metal (Aluminum, scrap iron, & copper; Limits apply)
 - Paint cans (Must be empty & dry)
 - Paper (No more than 5% of load)
 - Pipe (PVC & iron)
 - Plaster (Limits apply)
 - Plywood
 - Sheetrock (Limits apply)
 - Siding (Wood, Masonite, & Hardiplank)
 - Tar paper
 - Tile flooring (Ceramic & vinyl)
 - Tin
 - Toilets & bathtubs
 - Windows
 - Yard Waste

Please ask before putting items such as roofing shingles, sod, rocks, or bricks in the dumpster. These items are considered “heavy materials” and limits apply. Absolutely no CONCRETE OR DIRT!!! If you are not sure if an item can go in the dumpster, just ask! It is important that you abide by these guidelines to ensure that we are compliant with laws & regulations. If a dumpster is overloaded with any type of material and cannot be picked up, the customer will be responsible for unloading the dumpster to the point that it can be picked up. This will be determined by a Brave representative. Brave Environmental Site Services may assess a “dry run” fee to cover the costs incurred for not being able to pick up your dumpster.

*****Ragin' Container Rentals DOES NOT ALLOW MORE THAN 1 CUBIC YARD OF HEAVY MATERIALS (I.E. CONCRETE, ROCK, ASPHALT, PLASTER, BRICK, METAL, ETC. EXCEEDING CONTAINER WEIGHT LIMITS WILL RESULT IN CUSTOMER HAVING TO UNLOAD THE DUMPSTER AND/OR EXTRA CHARGES.*****

• WHAT IS NOT ALLOWED IN THE DUMPSTER?

Ragin Container Rentals, LLC **CANNOT** accept certain types of waste. This includes, but not limited to:

- Asbestos or Creosote
- Batteries (Any type)
- Chemicals (Lawn products, pesticides, etc.)
- Florescent bulbs
- Freon devices (A/C units, freezers, refrigerators, etc.)
- Fuels or fuel tanks (Gas, diesel, or propane)
- Hazardous materials
- Liquids (Paint, paint thinners, etc.)

- Oils (Food, hydraulic, or motor)
- Tires
- More than 1 cubic yard of heavy material (Exceeding the weight limit will result in extra charges.)

*****IF ANY OF THE ABOVE-MENTIONED ITEMS ARE DISCOVERED BY A BRAVE REPRESENTATIVE, THE CUSTOMER WILL BE RESPONSIBLE FOR UNLOADING THE DUMPSTER BEFORE IT WILL BE PICKED UP. RCR MAY ASSESS A “DRY RUN” FEE TO COVER THE COSTS INCURRED FOR NOT BEING ABLE TO PICK UP DUMPSTER. IF ANY OF THESE ITEMS ARE DISCOVERED AT LANDFILL, CUSTOMER WILL BE LIABLE FOR ANY AND ALL COSTS INCURRED TO REMOVE AND DISPOSE, AS WELL AS ANY PENALTIES, FINES OR FEES. *****

● **HOW MUCH CAN I PUT IN THE DUMPSTER?**

The dumpster can be filled to the “MAXIMUM LOADING LEVEL”, which is the top of the dumpster. By law, we are required to “contain” every load with a tarp to ensure safe hauling to the proper location. Ragin’ Container Rentals **CANNOT** safely remove a dumpster that has been over filled. The customer is responsible for ensuring that the dumpster is properly loaded. RCR may assess a “dry run” fee to cover costs incurred because of overloading. Our 15 yard container has a weight limit of 2 Tons; our 30 yard container 4 Tons. Overage charges shall be no less than \$72/Ton. If container is too heavy to be lifted, customer is responsible for unloading or fees associated with unloading.

● **DO I NEED TO BE PRESENT WHEN THE DUMPSTER IS DROPPED OFF?**

No, you do not have to be present when the dumpster is dropped off as long as the service agreement has always been signed, payment has been made, and all details, including location, have been discussed & verified. You do, however, need to be present if these things have not been taken care of. If the contract is cancelled when the dumpster is already in transit or the dumpster is declined upon arrival, Brave may assess a “dry run” fee.

● **DO I NEED TO BE PRESENT WHEN THE DUMPSTER IS PICKED UP?**

No, you do not have to be present, however, it is your responsibility to make sure that the dumpster is ready for pick up at the end of your contract. Please make sure that the container is not overfilled and there is nothing blocking the path to the dumpster.

● **WHAT IS Ragin’ Container Rentals NOT RESPONSIBLE FOR?**

RCR is extremely careful when delivering dumpsters to customers’ sites. It is your responsibility to inform Ragin’ Container Rentals of any underground features that may be in the path of the dumpster before it is delivered to the site. It is your responsibility to carefully choose your dumpster placement. Ragin’ Container Rentals **IS NOT RESPONSIBLE** for injuries or damage done due to delivery, placement, or pick up of our containers. RCR is not liable for accidents or injuries that may occur during your service period. It is further agreed upon that if litigation or arbitration arises between Ragin’ Container Rentals and the customer, that venue will rest in Breaux Bridge, Louisiana.

● **AM I RESPONSIBLE FOR ANY DAMAGE TO THE DUMPSTER DURING MY SERVICE PERIOD?**

The customer is responsible for any damage caused to the dumpster during the service period. Examples include, but are not limited to the following:

- Unauthorized movement of a dumpster causing damage or loss
- Pouring wet paint or other wet or sticky material into the dumpster
- Overspray of any kind that defaces or damages the surface/appearance of the dumpster
- Overloading the dumpster
- Using heavy equipment to drop heavy loads into the dumpster causing dents in the interior or exterior surfaces.

*****PLEASE TREAT THE DUMPSTER WITH RESPECT. ADDITIONAL CHARGES WILL APPLY FOR DUMPSTER REPAIR AND/OR CLEANING. *****

If dumpster is too heavy (or filled above top rim of container) to be loaded on trailer, customer is responsible for unloading + trip charge + any other costs incurred.

Price includes Delivery, Pick Up, and initial dump fee. Additional days over your rental term will be charged to your card at \$10/day.

Payment is due prior to delivery via credit card, which remains on file with RCR until rental is complete.
